Minutes:

Mask Mandate – Due to current Covid conditions and recommendations, we have altered the Club Mask Mandate. Masks are NOT required at OUTDOOR events. For INDOOR events, we continue to ask coaches and trainers to wear a mask at all times. Players should arrive and depart from indoor events fully masked, including pre- and post-game huddles. Players do not need to play while masked. Club will reevaluate as the season progresses.

Intramurals Update – Registration has been open for about 3 weeks. Approximately 177 players registered so far across all ages. Play will occur intra-club only, with

games taking place at Heebner and Arcola. Hard registration deadline date of March 9th.

Travel Update –

Standard email template is being provided to coaches to use if needed to advise opponent of possible Covid exposure.

Please continue to push team parents to complete Fall 2021 Survey. Approx 70 responses so far.

2022-23 Kits: Current plan is that jerseys will remain unchanged for at least one more year. Shorts and socks have a slight style update. No kit purchases will be required for returning players if size change not needed.

Club is looking into Veo and game recordings for use as a teaching tool that will benefit our players, coaches and trainers. Currently in initial stages of investigation and will update as learning and information gathering continues.

New evaluation process: 45-50 players submitted form. Coaches will receive list with applicable players. Coach to contact parents to setup eval dates-includes up to 8 sessions. Please keep trainers updated on those dates so they can expect new players. Will receive feedback from training staff on performance.

ALL players (prospective and current) will need to register and pay tryout fee-instructions to come. If player receives and accepts a place on team, the tryout fee is credited towards final cost. Process will start mid-Feb and team decisions/offers made by mid-April, with specific dates to be communicated.

Coaches should be thinking about their team plans and budgets now for the coming season, with the goal of having final plans in place with the club by mid-March.

Other Updates –

Refunds – Ralph is currently working through finalizing the accounts and hand off to Matt. Matt will be working on new expenses. Refunds/reimbursements have been prioritized.



Weather cancellations: we are currently looking to setup indoor and outdoor facilities for next year. Please note, the club is not charged if practices are canceled. If individual teams are interested in renting indoor turf, Far Post has some 1/2hr blocks for ¼ field available some Wednesdays/Saturdays. Call/email directly for more information.
